Read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. Is there a limit on the number of times a customer can enter?	There is no limit on the number of entries Every separate qualifying purchase made at checkout on Superbalist using your eBucks qualifies you for an entry into the draw.
Eligibility: Who qualifies to take part?	This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry, has an FNB/RMB Private Bank transactional account and is a member of the eBucks Rewards Programme.
