

**eB Travel and LIFT Flights
COMPETITION RULES**

Read these Competition rules carefully. These Competition rules ("rules") explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules. Promoter(s) Name(s):	This competition is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 ("eBucks")) an Authorised Financial service and Registered Credit provider, having its principal place of business at 01 st floor, 7 Merchant Place, 9 Fredman Drive, Sandton, 2196. eBucks Travel will be responsible for conducting the promotional competition on behalf of eBucks. In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
How to enter?	<ul style="list-style-type: none"> • Book a LIFT flight on the FNB App with eBucks Travel, during the period 1 – 30 September 2021 for travelling anytime. • Pay with your virtual card and confirm your ticket on the FNB App and you will automatically be entered into to the draw. • Valid for travel anytime • Qualifying tickets are valid on all classes on LIFT Airlines • Only the main member's ticket qualifies for the draw, and the main member must be travelling as part of the booking.
The prizes	<ul style="list-style-type: none"> • Winner will get 12 x return economy tickets for LIFT domestic flights for an entire year valid from the date of announcement to the winner. • While all classes qualify to go into the draw for the prize, the prize itself is Economy tickets. • Limited to 1 return ticket per month, the winner may start using their prize as of 18 October 2021. • Tickets are not transferable to the next month if not used. • Tickets do not have to be booked in the winner's name. • A prize letter will be sent to the winner after the winner has been announced. <p>All bookings to be done via LIFT directly.</p>

Entries close:	Entries close on 30 September 2021 at 11:59:59 pm. The promoter(s) reserve the right to extend the Competition by amending these Competition rules.
Is there a limit on the number of times you can enter?	There is no limit on the number of entries. Every separate booking of the LIFT flight on the FNB App using your virtual card will be an entry into the draw
Eligibility: Who qualifies to take part?	This competition is open to any legal resident of the Republic of South Africa who is either a natural person, 18 years of age or older and juristic persons registered in terms of the law of the Republic of South Africa. The persons must be a qualifying FNB/RMB Private Banking accountholder and a member of the eBucks Rewards Programme. Excluding the categories of people listed below who cannot take part.
Who cannot take part?	<p>The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them:</p> <ul style="list-style-type: none"> a) Any employee of the promoter(s). b) Any director, member, partner, agent of, or consultant of the promoter(s). c) Any other person who directly or indirectly controls the promoter(s).

How will winner(s) be chosen?	<p>A draw will take place during the week of 11 October 2021 to determine the winners. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk & Compliance team at eBucks. The winners will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the FNB Website within four days of the original draw date. The random entries drawn will be checked to establish whether they meet the Competition qualifying criteria and if so that entry will be the prize winners, subject to us being able to contact such winners within 48 (forty-eight) hours of the draw taking place. If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria.</p>
How and when will winner(s) names be announced?	<p>The prize winner will be contacted directly by eBucks Travel by 18 October 2021 and a Prize letter will be sent to the winner after the winner has been announced. The winner will also be announced on eBucks.com provided that the winner agrees to the announcement. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter, the prize will be awarded to the entrant who was drawn second or third and so on.</p>

We cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Competition agree that we will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a prize, or from participation in this Competition. Rule Amendments
