CAMPAIGN RULES**

Read these campaign rules carefully. These campaign rules (“rules”) explain your rights and duties in connection with this campaign. If you take part in this campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these campaign rules.

Promoter(s) Name(s):	This campaign is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”). An Authorised Financial service and Registered Credit provider. Having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000. The person responsible for conducting the promotional campaign on behalf of eBucks is Calche Msali, a Marketing Manager at eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
The Offers:	Get Apple TV+ free for one year when you buy a new iPhone, iPad, iPod touch, Apple TV+ or Mac. While stock lasts.
Campaigns opens:	01 March
Campaign closes:	31 March. The promoter(s) reserve the right to extend the campaign by amending these campaign rules.
Eligibility: Who qualifies to take part?	This campaign is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and an FNB/RMB Private Bank customer who is also a member of the eBucks Rewards Programme.
How to participate?	Get Apple TV+ free for one year when you buy a new iPhone, iPad, iPod touch, Apple TV or Mac. Make sure your eligible device is running the latest iOS, iPadOS, tvOS or macOS. Offer must be claimed in the Apple TV+ app within 3 months after first setting up your new device. To see the Offer, you will need to sign in or set up your Apple ID on your new device. Upon claiming the offer, you commit to a R84.99/month subscription that starts immediately after your 1 year free and automatically renews until cancelled. You can cancel at any time in Settings at least a day before each renewal date. If you cancel during your free year, you and your family members will immediately lose access to Apple TV+ and the remainder of your 1-year free trial.
Products to which the Offer is Applicable:	Any new iPhone, iPad, iPod touch, Apple TV or Mac capable of running the latest iOS, iPadOS, tvOS or macOS purchased after 01 March 2021, from Apple or an Apple authorized reseller, is eligible.
Is there a limit on the number of Offers?	<ul style="list-style-type: none"> • Offer cannot be combined with other free trials or offers for Apple TV+. • Only one offer per Family, regardless of number of devices purchased. You can share your 1 free year of Apple TV+ with up to 5 other family members via Family Sharing. Once you cancel the offer before the 1year ends, you will not be able to reactivate the trial Offer.
Data Usage and Privacy Policy	Participants in the campaign understand and agree that, in order to offer the campaign, eBucks may collect and use personal information about participants. This personal information may include participants’, first name, last name, email address, mobile number and in certain instances your image.
