Read these Campaign rules carefully. These Campaign rules explain your rights and duties in connection with this Campaign. If you take part in this Campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Campaign rules.

Promoter(s) Name(s):	This Campaign is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”), an Authorised Financial Services and Registered Credit Provider having its principal place of business at 6 Merchant Place, 2nd Floor, 9 Fredman Drive, Sandton, Gauteng, South Africa, 2000, in collaboration with AVIS. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”. These rules must be read in conjunction with eBucks Terms and Conditions and subject to AVIS’s Terms and Conditions.
The Campaign:	<p>Customers can get 1-day Free Rental plus 20% back in eBucks on their Rand spend, as set out below:</p> <ul style="list-style-type: none"> • Book your car hire on the FNB/RMB Banking App or eBucks website during Pay Day (15th May or 15th June 2026 between 00:01pm and 23:59pm) to qualify for 1 Free Day of rental plus 20% back in eBucks on your rand spend. • Pricing on the FNB/RMB Banking App will already include the 1-day Free Rental. • The following customers qualify: FNB Aspire, FNB Premier, FNB Private Clients, FNB Private Wealth, RMB Private Bank customers, FNB Gold Business, FNB Platinum Business, FNB Enterprise Business, FNB Healthcare and Private Business and RMB Private Bank Business. • eBucks car hire discounts apply over and above the total price for qualifying customers. • There is no minimum or maximum car rental duration required to qualify for the 20% back in eBucks. • A minimum of (3) three-days rental (inclusive of the 1 Free Day rental) is required to qualify for the 1-day Free Rental. • A maximum of 21 (twenty-one) days rental (inclusive of the 1 Free Day rental) is required to qualify for the 1-Day Free Rental. • Customers will be allowed to make 1 (one) change to their car hire within (60) sixty days of the original booking date. The 1-day Free Rental will still apply provided the booking remains within the existing rules (the minimum and maximum rental period). Any changes outside of the (60) sixty days will follow standard process and normal rates will apply. Changes are subject to best available rate of the day at time of change. • eBucks earned will be paid out to the main member in the following months’ pay out period, which falls on or around the 15th of that month. • Car hire bookings are available on all car groups.

Make payment with your qualifying FNB or RMB Private Bank Card.

Transacting person must have legal authority to transact on the account. FNB Easy customers are excluded from this campaign.</p>
<p>Is there a maximum spend cap for the eBucks earn?</p>	<p>eBucks earn will be calculated on any amount of your rand spend only.</p>

IMPORTANT
