

## FNB Burger Fridays with Pick n Pay Campaign

### CAMPAIGN RULES

Read these campaign rules carefully. These campaign rules explain your rights and duties in connection with this Campaign. If you take part in this campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these campaign rules.

<b>Promoter(s) Name(s):</b>	This campaign is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 ("eBucks")). An Authorised Financial service and Registered Credit provider. Having its principal place of business at 2 <sup>nd</sup> Floor, 6 Merchant Place, 9 Fredman Street, Sandton, Gauteng, South Africa, 2000, in collaboration with Pick n Pay Retailers Pty Ltd (Pick n Pay). In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
<b>The Offer:</b>	Pay just R50 for the FNB Burger Friday deal at PnP
<b>Campaign opens:</b>	06 March 2026
<b>Campaign closes:</b>	26 June 2026
<b>Eligibility: Who qualifies to take part?</b>	<p>This promotion is exclusively for participants who are registered Pick n Pay Smart Shoppers and FNB eBucks members. Participants need to have both a registered Smart Shopper card as well as a First National Bank retail card under the same customer name, with matching South African ID number or passport numbers. If the card details do not match, the participants will not be able to receive the benefit of the offer.</p> <p>The participant needs to have registered their Smart Shopper card and successfully applied for a FNB retail bank card (Easy, Aspire, Premier, Private Clients, Private Wealth or RMB Private Bank) and be eligible for rewards, at least fourteen (14) business days prior to participating in the promotion. All of these requirements must be met to be eligible the promotion.</p>

The transaction will not go through if the customer attempts to pay with cash or any other bank card.

The Burger Friday promotional offer is valid while stocks last.

**Is there a limit on the number of times you can participate in the FNB deal?**

This offer is limited to one (1) FNB combo deal per customer per Friday. Should this limit be exceeded, PnP and FNB reserve the right to exclude a customer from future promotions.

**Is the Smart Shopper Burger Friday for R100 limited?**

The Smart Shopper Burger Friday deal for R100 is unlimited. A customer can buy as many R100 Smart Shopper Burger Friday deals as they wish.

**Can I pay with another card or cash?**

The Campaign is linked to the customer making payment with an FNB card only (plastic or virtual). No other card or cash will be accepted for the FNB deal.

If an FNB card is not present the deal will revert to the R100 Smart Shopper price by the PnP cashier and another tender may be used at this point.

**Data Usage and Privacy Policy**

Participants in the campaign understand and agree that, in order to offer the Campaign, FNB eBucks may collect and use personal information about participants. This personal information may include participants' first name, last name, email address and mobile number. FNB eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties.
