The person responsible for conducting the promotional Campaign on behalf of eBucks is Erica Webb, a Partner Growth Manager at eBucks.</p> <p>In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.</p>
<b>The Campaign:</b>	You as an eBucks member will automatically qualify to get 10% back in eBucks when spending eBucks on fuel at participating Engen service stations.

<b>Campaign closes:</b>	<p>The Campaign closes on 18 June 2018 at 23:59:59pm</p> <p>The promoter(s) reserve the right to extend the Campaign. Notice of this will be posted in these rules, should it be necessary.</p>
<b>Eligibility: Who qualifies to take part?</b>	<p>This campaign is open to all natural persons over the age of 18 who are legal residents of the Republic of South Africa and are members of the eBucks Rewards Programme.</p> <p>Eligibility is based on eBucks spent on fuel at participating Engen service stations only.</p>
<b>How to participate</b>	Customers will receive a mailer an SMS alerting them to the campaign.
<b>Is there a limit on the number of times I can spend my eBucks?</b>	There is no limit to the amount of eBucks you can spend. You will receive an additional 10% allocation in eBucks based on your eBucks spent on fuel at selected Engen service stations nationwide during the campaign period.
<b>Data Usage and Privacy Policy</b>	<p>Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants’ first name, last name, email address, mobile number and in certain instances your image. Personal data, which participants provide when they enter the Campaign, may, subject to prevailing law, be used for future eBucks marketing activity, unless you notify eBucks that you wish to opt out of receiving such marketing communications. eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties. eBucks may disclose information if required to do so by law or if it is required to protect the safety, rights or property of the eBucks, our members, customers or the public.</p>

## IMPORTANT

- You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the campaign rules. - The promoter(s) have the right to end this campaign at any time. If this happens you agree to waive (give up) any rights that you may have about this campaign and agree that you will have no rights against the promoter(s).
- The promoter(s) reserve the right to change the rules of the campaign. The promoter(s) can change the rules of the campaign throughout the duration of the campaign. For convenience only, the date on which these rules were last amended will be shown below the heading. It is your responsibility to check the rules for amendments.
- The clauses in these rules are severable. This means that if any clause in these rules is found to be unlawful, it will be removed and the remaining clauses will still apply.
- Where any dates or times need to be calculated in terms of this agreement, the international standard time: GMT plus two hours will be used.
- While the promoter(s) may allow you extra time to comply with your obligations or decide not to exercise some or all of our rights, or waive certain requirements, the promoter(s) can still insist on the strict application of any or all of its rights at a later stage. You must not assume that this means that the rules have been changed or that it no longer applies to you.
