In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants and winners as “you”.

This Campaign is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is an FNB GOLD CHEQUE CARD account holder. Including, but not limited to, being a member of the eBucks rewards program, having an account which is in good standing and must have been KYC’d by FNB and will receive either an SMS, email or App notification requesting them to download, login and register for the FNB Banking App .
