

# FNB Offers “Credit Card Spend” Campaign

Read these Campaign rules carefully. These Campaign rules (“rules”) explain your rights and duties in connection with this Campaign. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants and winners as “you”.															
<b>The Campaign:</b>	Swipe or Tap your FNB Credit Card in store between 01 September 2019 and 11 October 2019 and get rewarded. Minimum spend amount is as per the table below.															
<b>Campaign start date:</b>	01 September 2019.															
<b>Campaign closes:</b>	11 October 2019.  The promoter(s) reserve the right to extend the Campaign by amending these Campaign rules. Notice of this will be posted in these rules.															
<b>Eligibility: Who qualifies to take part?</b>	This Campaign is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is an <b>FNB GOLD/PREMIER/PRIVATE CLIENTS/PRIVATE WEALTH</b> account holder. Customers will be selected to participate in the Campaign based on their individual profile meeting the minimum required criteria for the campaign, including, but not limited to, being a member of the eBucks rewards program, having an account which is in good standing and must have been KYC'd by FNB and will receive either an SMS, email or App notification requesting them to <b>Spend with their Credit Card</b> .
