

# FNB Offers “Personal Loan Take up” Campaign

## CAMPAIGN RULES

Read these Campaign rules carefully. These Campaign rules (“rules”) explain your rights and duties in connection with this Campaign. If you take part in this Campaign and/or accept any reward, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound these Campaign rules.

<b>Promoter(s) Name(s):</b>	This Campaign is run by FNB-eBucks (“eBucks”), a division of FirstRand Bank Limited with Reg. No. <b>1929/001225/06</b> having its principal place of business at FNB Place, 30 Diagonal Street, Johannesburg. The person responsible for conducting the promotional Campaign on behalf of eBucks is Cezanne Samuel, Head of FNB Offers. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants and winners as “you”.															
<b>The Campaign:</b>	Take up a Personal Loan from FNB <b>and authorise repayment via a monthly debit order</b> , between 01 August 2019 and 31 August 2019, and get rewarded with R400 Dis-Chem voucher or eBucks (eB4000). Minimum loan amount is as per the table below.

<b>Eligibility: Who qualifies to take part?</b>	This Campaign is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is an <b>FNB GOLD/PREMIER/PRIVATE CLIENTS/PRIVATE WEALTH</b> account holder. #### **IMPORTANT**
