

FNB Offers “Personal Loan Take up” Campaign

Read these Campaign rules carefully. These Campaign rules (“rules”) explain your rights and duties in connection with this Campaign. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants and winners as “you”.

This Campaign is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is an FNB GOLD/PREMIER/PRIVATE CLIENTS/PRIVATE WEALTH account holder. Customers will be selected to participate in the Campaign based on their individual profile meeting the minimum required criteria for the campaign, including, but not limited to, being a member of the eBucks rewards program, having an account which is in good standing and must have been KYC’d by FNB and will receive either an SMS, email or App notification requesting them to take up a Personal Loan .
