Read these Campaign rules carefully. These Campaign rules explain your rights and duties in connection with this Campaign. If you take part in this Campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Campaign rules.

Promoter(s) Name(s):	This campaign is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (“eBucks”). An Authorised Financial service and Registered Credit provider. Having its principal place of business at 6 Merchant Place, 2nd Floor, Fredman Drive, Sandton, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Mr Delivery (Pty) Ltd (“Mr D Food”). In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
The Offer:	R100 (one hundred rands) Mr D voucher with each QuickBus booking <ul style="list-style-type: none"> - Book your bus ticket with eBucks Travel on App between 1 Nov – 30 Nov, for travel at any time. - A R100 (one hundred rands) Mr D voucher will be allocated to each booking. - The voucher can only be used on the Mr D App for minimum orders of R120 excluding delivery costs - Your voucher will be sent to you via an App notification and will be saved under “Vouchers” on the banking App by 13 December 2024 - Your voucher is valid until 31 March 2025. - This voucher can only be redeemed once; therefore purchases should be equal to or above voucher value.
Campaign opens:	The Campaign starts on 1 November 2024 at 08:00 am.
Campaign closes:	The Campaign ends on 30 November 2024 at 11:59:59pm The promoter(s) reserves the right to extend the Campaign by amending these Campaign rules.
Eligibility:	FNB Easy Bundle, FNB Aspire and FNB Premier account holders.
Who qualifies to take part?	This Campaign is open to anyone who is a qualifying FNB account holder, who is a legal resident of the Republic of South Africa and is a natural person 18 years of age or older at the time of redemption.
How to participate?	Book a bus ticket with Quickbus on the FNB App
Products to which the Discount is Applicable (“discounted item”):	This offer is valid on Mr D Food orders with a minimum spend of R120, excluding deliveries. The offer cannot be used for grocery, convenience and liquor store orders.
Is there a limit on the number of times you can use the discount voucher?	You can make as many bus bookings as you wish, each booking will qualify for a R100 (one hundred rands) Mr D voucher.
Data Usage and Privacy Policy	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants’ first name, last name, email address, mobile number and in certain instances your image. eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties. eBucks may disclose information if required to do so by law or if it is required to protect the safety, rights or property of the eBucks, our members, customers or the public.

IMPORTANT
