

Le Creuset 2018 Rules

Read these competition rules carefully. These competition rules (“rules”) explain your rights and duties in connection with this competition. If you take part in this competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these rules.

Is there a limit on the number of times you can enter?	The offer is limited to 1 promo code per person. Participants who pay or part-pay, in any amount of eBucks, at any of the Le Creuset stores nationwide, will qualify for the discount on selected Le Creuset gift sets. NB: Participants need to use eBucks, either in whole or in part to qualify. Using an FNB card (other than an eBucks card) to pay in full will not qualify. Use voucher code eBucks2018 to qualify for the 20% discount on selected Le Creuset gift sets.
Eligibility: Who qualifies to take part? Participants in this Competition agree that we will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a prize, or from participation in this Competition. The laws of the Republic of South Africa govern this Competition. If any provision or part of these Rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these Rules shall remain in force. IMPORTANT
