### FNB CAMPAIGN RULES

**Date these rules were first published: 21 February 2024**

**Date these rules were last changed: 5 March 2024**

Read these Campaign rules carefully. These Campaign rules explain your rights and duties in connection with this Campaign. If you take part in this Campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Campaign rules.

<b>Campaign Name:</b>	Get a R50 Mr D food voucher code with every QuickBus booking on the FNB App.
<b>Promoter(s) Name(s):</b>	This campaign is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 ("eBucks")). An Authorised Financial service and Registered Credit provider. Having its principal place of business at 6 Merchant Place, 2nd Floor, Fredman Drive, Sandton, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Mr Delivery (Pty) Ltd ("Mr D Food"). In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
<b>The Campaign:</b>	<p>This campaign offers FNB customers a R50 voucher code to use with Mr D Food restaurant orders when they book a bus ticket with QuickBus on the FNB App between 18 March-30 April 2024.</p> <ul style="list-style-type: none"><li>• Customers can travel at any time</li><li>• Campaign applies to Easy Smart and Aspire customers only</li><li>• 1 voucher code per booking (not per passenger)</li><li>• Bus bookings can be one way or return</li><li>• Voucher codes are subject to availability and valid for first 2000 bookings only</li><li>• Valid for both qualifying and non-qualifying eBucks members</li><li>• R50 voucher codes can only be used on Mr D for minimum orders of R120 excluding delivery costs</li><li>• Can be used in conjunction when paying in eBucks</li><li>• Each voucher code is unique and can only be used once</li><li>• Voucher code is only valid for participating Mr D restaurants in South Africa</li><li>• Voucher codes will be sent to qualifying customers between 1-17 May 2024 (will be available under 'vouchers' on the FNB App)</li><li>• Voucher codes will expire on 31 July 2024</li><li>• The voucher code has no cash value and cannot be combined with any other discounts, voucher codes or promotions;</li><li>• Successful redemption of the voucher code is subject to the availability and acceptance of the order, by the Mr D Food restaurant partner with whom the qualifying order was placed;</li><li>• Access to and use of the Mr D Food App will be subject to Mr D Food's terms and conditions and privacy statement applicable to all customers who use the platform.</li></ul>
<b>Campaign opens:</b>	The Campaign starts on 18 March 2024 at 08:00 am.
<b>Campaign closes:</b>	The Campaign ends on 30 April 2024 at 11:59:59pm or when 2000 redemptions have been met, whichever occurs first. The promoter(s) reserves the right to extend the Campaign by amending these Campaign rules.
<b>Eligibility: Who qualifies to take part?</b>	FNB Easy Smart and Aspire customers only. This Campaign is open to anyone who is an FNB account holder, who is a legal resident of the Republic of South Africa and is a natural person 18 years of age or older at the time of redemption.
<b>How to participate?</b>	<p>Book a bus ticket via QuickBus on the FNB App between 18 March-30 April 2024</p> <ul style="list-style-type: none"><li>• Log into the FNB App</li><li>• Select eBucks</li><li>• Select Travel</li><li>• Go to "Book bus"</li></ul> <p>After the campaign period, you will receive a Mr D voucher code (under vouchers) on the FNB App</p> <p>How to use the Mr D voucher code:</p> <ul style="list-style-type: none"><li>• Download or open the Mr D Food app</li><li>• Register or log in to your profile</li><li>• Place an order of R120 or more, excluding delivery cost and any service cost which might be charged, and check out</li><li>• In the payment screen, enter the voucher code <b>as sent via FNB</b></li><li>• Complete the checkout process</li></ul>

<b>Products to which the Discount is Applicable (“discounted item”):</b>	<ul style="list-style-type: none"> <li>• This offer is valid on Mr D Food restaurant orders of at least R120 or more.</li> <li>• The offer cannot be used for grocery, convenience and liquor store orders.</li> </ul>
<b>Is there a limit on the number of times you can use the discount voucher?</b>	The offer is limited to every bus booking, so if customers make more than one qualifying booking during the campaign period, they could qualify for more than one voucher.
<b>Data Usage and Privacy Policy</b>	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants’, first name, last name, email address, mobile number and in certain instances your image. eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties. eBucks may disclose information if required to do so by law or if it is required to protect the safety, rights or property of the eBucks, our members, customers or the public.

Participants in this Campaign agree that eBucks will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a code, or from participation in this Campaign. The laws of the Republic of South Africa govern this Campaign. If any provision or part of these rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force. Any violation of these rules will result in the immediate disqualification of the transgressing participant from the Campaign.
<b>Rule Amendments</b>	These rules cannot be modified or superseded except by eBucks, in its reasonable discretion, in a written revision to these rules posted on the eBucks website and, at eBucks’ sole discretion, using other potential official Campaign communication methods reasonably calculated to reach a majority of potential participants. **IMPORTANT**

## GENERAL RULES

- Unless we say otherwise you must be at least 18 to enter.

- You are responsible for the tax associated with using or accepting any discount.
- You may not attempt to do anything to change the outcome of the Campaign in any way.
- The promoter(s) decision is final and no correspondence will be entered into. This means you cannot appeal any decision by the promoter(s).
- The promoter(s) have the right to end this Campaign at any time. If this happens you agree to waive (give up) any rights that you may have about this Campaign and agree that you will have no rights against the promoter(s).
- The promoter(s) reserve the right to change the rules of the Campaign. The promoter(s) can change the rules of the Campaign throughout the duration of the Campaign. For convenience, only, the date on which these rules were last amended will be shown below the heading. It is your responsibility to check the rules for amendments.
- The clauses in these rules are severable. This means that if any clause in these rules is found to be unlawful, it will be removed and the remaining clauses will still apply.
- Where any dates or times need to be calculated in terms of this agreement, the international standard time: GMT plus two hours will be used.
- While the promoter(s) may allow you extra time to comply with your obligations or decide not to exercise some or all of our rights, or waive certain requirements, the promoter(s) can still insist on the strict application of any or all of its rights at a later stage. You must not assume that this means that the rules have been changed or that it no longer applies to you.
