Having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Mr Delivery (Pty) Ltd ("Mr D Food"). In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
The Discount:	<p>This campaign offers FNB/RMB PB customers R50 off their first 3 Mr D Food orders, when they spend R100 or more on the Mr D Food app orders in South Africa, where Mr D Food is available during the campaign period.</p> <ul style="list-style-type: none"> • In order to qualify for the discount, a first time Mr D Food user needs to apply their coupon code LOVEFOOD2020 each time, for the first 3 orders placed on the Mr D Food mobile application; • The coupon code has no cash value and cannot be combined with any other discounts, coupon codes or promotions; • Successful redemption of the coupon code is subject to the availability and acceptance of the order, by the Mr D Food Restaurant partner the qualifying order was placed with; • Access to and use of the Mr D Food App will be subject to Mr D Foods Terms and Conditions and Privacy Statement applicable to all customers who use the platform.

Eligibility: Who qualifies to take part?	This Campaign is open to anyone who has an FNB/RMB PB account holders and has downloaded both the FNB and Mr D Food App, is a legal resident of the Republic of South Africa and is a natural person 18 years of age or older at the time of redemption.
How to participate?	<ul style="list-style-type: none"> • Participant downloads the Mr D Food app • Participant registers. • Participant places order and checkouts • In payment screen participant enters coupon code LOVEFOOD2020 • Chooses payment method and completes order <p>The coupon code will only be applicable for a customer's first 3 orders on the Mr D Food app and needs to be entered separately for each order placed.</p>
Products to which the Discount is Applicable ("discounted item"):	This offer is valid on a customer's first 3 Mr D Food orders of at least R100 made through the Mr D Food app, excluding delivery cost and any service cost which might be charged by Mr D Food.
Is there a limit on the number of times you can use the discount voucher?	The offer is limited to the first 3 orders on the users Mr D Food profile, of at least R100 each.
Data Usage and Privacy Policy	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants' first name, last name, email address, mobile number and in certain instances your image. 	resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a code, or from participation in this Campaign. The laws of the Republic of South Africa govern this Campaign. If any provision or part of these rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force.
