Read these campaign rules carefully. These campaign rules ("rules") explain your rights and duties in connection with this campaign.

If you take part in this campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these campaign rules.

In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".

<b>Data Usage and Privacy Policy</b>	Participants in the campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants’ first name, last name, email address, mobile number and in certain instances your image. #### IMPORTANT
