

# FNB and Engen New Litres Campaign

## CAMPAIGN RULES

**Dates: 5 March 2026 - ongoing (to be continued and assessed monthly)**

Read these Campaign rules carefully. These Campaign rules explain your rights and duties in connection with this Campaign. If you take part in this Campaign and/or accept any discount, these rules will apply to you, and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Campaign rules.

<b>Campaign Name:</b>	FNB and Engen New Litres Campaign
<b>Promoter(s) Name(s):</b>	This campaign is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”). An Authorised Financial service and Registered Credit provider. Having its principal place of business at 2nd Floor, 6 Merchant Place, 9 Fredman Street, Sandton, Gauteng, South Africa, 2000 in collaboration with Engen. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”. The person responsible for conducting the promotional campaign on behalf of eBucks is Malcom Mathabire - Partner Growth Manager.
<b>The Voucher:</b>	<p>This offer entitles selected FNB customers to a R100 or R200 fuel voucher at any Engen in South Africa:</p> <ul style="list-style-type: none"> <li>• A user can apply their unique promotional code only once during the campaign period.</li> <li>• The voucher has a cash value but cannot be redeemed for cash.</li> <li>• The voucher will be available to be redeemed on the FNB app for 2 months whereafter this voucher will be needed to be loaded onto the Engen 1app.</li> <li>• Once the voucher has been loaded onto the Engen 1app, the voucher will be valid for 3 years from the date that the voucher is loaded on the Engen 1app.</li> <li>• Access to and use of Engen 1app will be subject to Engen’s Terms and Conditions and Privacy Statement applicable to all who use the platform.</li> <li>• The voucher will be made available on the FNB App within 1 month after the qualification month e.g. if a customer meets qualifying criteria in March, the voucher will be available during the month of April.</li> </ul>
<b>Campaign opens:</b>	The Campaign starts on 5 March 2026 at 00:00:01am.
<b>Campaign closes:</b>	The Campaign will continue and will be assessed on a month-on-month basis. The promoter(s) reserve the right to end the Campaign by amending these Campaign rules.
<b>Eligibility: Who qualifies to take part?</b>	This Campaign is open to legal resident of the Republic of South Africa who is a natural person, 18 years of age or older, has an FNB transactional account, and is a member of the eBucks Rewards Programme. 	<ul style="list-style-type: none"> <li>• Register using your email address or a social account,</li> <li>• Navigate to your 1 Wallet, tap on your 1 Card and then tap on Top Up 1 Card to enter your Top Up Code;</li> <li>• To use your code, select 1 Card as your payment method.</li> </ul>
<b>Products to which the Discount is Applicable (“discounted item”):</b>	This offer is valid for fuel purchases at Engen.
<b>Is there a limit on the number of times you can use the discount voucher?</b>	The promotional code can only be redeemed once during the campaign period.
<b>Data Usage and Privacy Policy</b>	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants’, first name, last name, email address, mobile number and in certain instances your image. Personal data, which participants provide when they enter the Campaign, may, subject to prevailing law, be used for future eBucks marketing activity, unless you notify eBucks that you wish to opt out of receiving such marketing communications. eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties. eBucks may disclose information if required to do so by law or if it is required to protect the safety, rights or property of the eBucks, our members, customers or the public. <b>General</b>	No correspondence will be entered into regarding either this Campaign or these rules. In the unlikely event of a dispute, eBucks’ decision shall be final. eBucks reserves the right to amend, modify, cancel or withdraw any aspect of this Campaign in its sole discretion at any time without notice or liability. eBucks cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Campaign agree that eBucks will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a code, or from participation in this Campaign. The laws of the Republic of South Africa govern this Campaign. If any provision or part of these rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force. ### **IMPORTANT**
