**COMPETITION RULES**

Read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

<b>Competition Name:</b>	FNB/RMB customers stand a chance to win weekly spot prizes when shopping on One Day Only during the competition period.
<b>Promoter(s) Name(s):</b>	This Competition is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”)), an Authorised Financial services and Registered Credit provider having its principal place of business at 7 Merchant Place, 1 <sup>st</sup> Floor, 9 Fredman Drive, Sandton, Gauteng, South Africa, 2000, in collaboration with Clicks. The person responsible for conducting the promotional Competition on behalf of eBucks is Patricia Sishi, a Partner Growth Manager at FNB-eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
<b>The Competition:</b>	Use your FNB/RMB Private Bank qualifying card or ebucks when shopping on One Day Only and be entered into the weekly draw where you stand a chance to win 1 of 5 R1000 vouchers from 17 November – 24 December 2021.
<b>How to participate/enter?</b>	Use your FNB/RMB Private Bank qualifying card or eBucks when shopping on One Day Only.
<b>The prizes</b>	1 of 5 R1000 vouchers per winner.
<b>Competition starts on:</b>	Competition starts on 17 November 2021 at 00:00:01am.
<b>Competition ends on:</b>	Competition ends on 24 December 2021 at 11:59:59 pm. The promoter(s) reserve the right to extend the Competition by amending these rules.
<b>Is there a limit on the number of times a customer can enter?</b>	<p>There is no limit on the number of entries, there is however a minimum order value of R200 to qualify, excluding delivery costs.</p> <p>Every separate qualifying purchase made at checkout of R200 or more on One Day Only using your FNB/RMB Private Bank qualifying card or eBucks qualifies a customer.</p>
<b>Eligibility: Who qualifies to take part?</b>	This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry, has an FNB/RMB Private Bank transactional account and is a member of the eBucks Rewards Programme.

<p><b>How will winner(s) be chosen?</b></p>	<p>Weekly draws will take place from the 24<sup>th</sup> November 2021 to determine the winners. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk &amp; Compliance team at One Day Only</p> <p>Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published via official One Day Only social media platforms. The random entries drawn will be checked to establish whether they meet the Competition qualifying criteria and if so that entry will be the prize winners, subject to One Day Only being able to contact such winners within 48 (forty-eight) hours of the draw taking place. If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria</p>
<p><b>How and when will winner(s) names be announced?</b></p>	<p>The prize winner(s) will be contacted directly by One Day Only weekly from the 24<sup>th</sup> November 2021. The winner will be contacted via e-mail or contact number as per One Day Only profile. The winner will also be announced on eBucks.com provided that the winner agrees to the announcement. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter, the prize will be awarded to the entrant who was drawn second or third and so on.</p> <p>The prize winner(s) determined after the 22<sup>nd</sup> December 2021 will receive their prize(s) by no later than the 17<sup>th</sup> January 2021.</p>
<p><b>How will winners receive the prizes?</b></p>	<p>Wallet credit on the winners' profile will be provided to the customer by One Day Only and can be used as many times/on as many deals until the credit has run out.</p>
<p><b>Data Usage and Privacy Policy</b></p>	<p>Participants in the Competition understand and agree that in order to offer the Competition, we may collect and use personal information about participants. This personal information may include a participant's first name, last name, email address, mobile number and in certain instances your image. Personal data, which participants provide, may, subject to prevailing law, be used for future eBucks marketing activity, unless you notify eBucks that you wish to opt out of receiving such marketing communications. We will treat your information in total confidence and will not sell, share or rent this information to any other third parties. We may disclose information if required to do so by law or if it is required to protect the safety, rights or property of eBucks, our members, customers or the public.</p>

In the unlikely event of a dispute, eBucks' decision shall be final. eBucks reserves the right to amend, modify, cancel or withdraw any aspect of this Competition in its sole discretion at any time without notice or liability. eBucks cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. The laws of the Republic of South Africa govern this Competition. If any provision or part of these rules is deemed void or otherwise unenforceable in law, then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force.
