<b>How to participate?</b>	Customers will receive a mailer and/or SMS alerting them to the campaign. The mailer and/or SMS will include the relevant discount coupons. These coupons can only be redeemed either online at <a href="http://www.zando.com">www.zando.com</a> or via the Zando app. To qualify for the offer, participants must enter the relevant coupon code on the checkout page before payment is made.
<b>Products to which the Discount is Applicable (“discounted item”):</b>	The offer is not valid on sale items, and cannot be combined with another gift voucher or promotional coupon code for an accumulated discount.
<b>Is there a limit on the number of times you can use the discount voucher?</b>	The offer is limited to one coupon code (FASHION30) per customer.

#### IMPORTANT
