Read these Campaign rules carefully. These Campaign rules explain your rights and duties in connection with this Campaign. If you take part in this Campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Campaign rules.

Promoter(s) Name(s):	This campaign is run by FNB-eBucks Rewards, a business unit within FirstRand Bank Limited Registration No. 1929/001225/06 ("eBucks") having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Uber BV. In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
The Discount:	<p>This offer entitles FNB customers to R75 off their next 3 orders, when they spend R100 or more on any Uber Eats orders (excluding delivery costs) in South Africa where Uber Eats is available during the campaign period.</p> <p>A user can apply their unique promotional code only once during the campaign period, and the promotional code will be valid only for the duration of the campaign period. The promotional code has no cash value and cannot be combined with any other discounts, codes or promotions. Successful redemption of the promotional code is subject to the availability of Uber delivery-partners at the time of requesting.</p> <p>Access to and use of the Uber Eats App will be subject to Uber's Terms and Conditions and Privacy Statement applicable to all eaters who use the platform.</p> <p>The promoters reserve the right to substitute the discounted item with other items of equal or greater value. Income or other taxes relating to the discount, if any, are the sole responsibility of the participants.</p>
Campaign opens:	The Campaign starts on 22 November 2019 at 08:00 am.
Campaign closes:	The Campaign ends on 31 December 2019 at 11:59:59pm. The promoter(s) reserve the right to extend the Campaign by amending these Campaign rules.
Eligibility: Who qualifies to take part?	This Campaign is open to anyone who has downloaded both the FNB and Uber Eats apps, is a legal resident of the Republic of South Africa, and is a natural person 18 years of age or older at the time of entry.
How to participate?	<p>The codes will be loaded for eBucks customers on the FNB App. To redeem the code:</p> <ul style="list-style-type: none">• Tap "Buy" on the home screen of the FNB App;• Tap "Vouchers + coupons";• Your voucher code will appear under the Vouchers tab. <p>To redeem the code on the Uber Eats App;</p> <ul style="list-style-type: none">• Open the Uber Eats App,• Tap on your profile,• Tap "promotions",• Tap "add promo" and input the code received on the FNB App;• Refresh the Uber Eats App,• The code will be added and automatically applied to the next 3 orders of R100 or more.
Products to which the Discount is Applicable ("discounted item"):	This offer is valid on 3 orders of at least R100 made through the Uber Eats app, excluding delivery costs.
Is there a limit on the number of times you can use the discount voucher?	The offer is limited to 3 orders of at least R100, excluding delivery costs.
Data Usage and Privacy Policy	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants', first name, last name, email address, mobile number and in certain instances your image. Personal data, which participants provide when they enter the Campaign, may, subject to prevailing law, be used for future eBucks marketing activity, unless you notify eBucks that you wish to opt out of receiving such marketing communications. eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties. eBucks may disclose information if required

General	No correspondence will be entered into regarding either this Campaign or these rules. In the unlikely event of a dispute, eBucks' decision shall be final. eBucks reserves the right to amend, modify, cancel or withdraw any aspect of this Campaign in its sole discretion at any time without notice or liability. eBucks cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Campaign agree that eBucks will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a code, or from participation in this Campaign. The laws of the Republic of South Africa govern this Campaign. If any provision or part of these rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force. Any violation of these rules will result in the immediate disqualification of the transgressing participant from the Campaign.
Rule Amendments	These rules cannot be modified or superseded except by eBucks, in its reasonable discretion, in a written revision to these rules posted on the eBucks website and, at eBucks' sole discretion, using other potential official Campaign communication methods reasonably calculated to reach a majority of potential participants. IMPORTANT
