Read these Promotional Campaign rules carefully. These Promotional Campaign rules explain your rights and duties in connection with this Promotion. If you take part in this Promotion and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Pilot rules.

Promoter(s) Name(s):	This Promotional Campaign is run by FNB-eBucks, a business unit within FirstRand Bank Limited Registration No. 1929/001225/06 ("eBucks") having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Uber South Africa. The person responsible for conducting the promotional campaign on behalf of eBucks is Bruce Gibbs, a Partner Growth Manager at eBucks. In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".

This means that the total discount will not exceed R300 and the discount for each Uber ride will not exceed R100.</p> <p>This offer is valid for the duration of this campaign.</p> <p>The promoters reserve the right to substitute the discounted item with other items of equal or greater value. Income or other taxes relating to the discount, if any, are the sole responsibility of the participants.</p>

Promotional Campaign closes:	<p>The Promotional Campaign ends on 30 November 2018 at 11:59:59pm.</p> <p>The promoter(s) reserve the right to extend the Promotional Campaign by amending these Campaign rules.</p>
Eligibility: Who qualifies to take part?	<p>This Promotion is open to anyone who is an active Uber user, a legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry, has been selected by eBucks and is a member of the eBucks Rewards Programme.</p> <p>NB: Participants will be selected solely at FNB eBucks' discretion.</p>
How to participate?	<p>4000 customers will be randomly selected to participate in this Uber campaign, and will receive a unique SMS code from eBucks relating to the discount (maximum amount of R100 off on each of the next 3 rides in the month of November 2018).</p> <p>To participate;</p> <ul style="list-style-type: none">• open the Uber App,• tap on menu,• tap "payment",• add the unique SMS code received from eBucks under promotions,• type in your promo code,• tap "add".

Products to which the Discount is Applicable (“discounted item”):	This offer is valid on your next 3 Uber rides within the Promotional Campaign period only.
Is there a limit on the number of times you can use the discount voucher?	The offer is limited to one unique SMS code per customer and is valid for 3 Uber rides with up to R100 discount per Uber ride.
Terms of Use	<ul style="list-style-type: none"> • The voucher may only be used in the conjunction with your qualifying FNB account number; • The voucher may only be used in the Uber App of the FNB account holder; • The R100 discount is only valid once-off per ride, should the ride be of a lesser value, the difference may not be exchanged for money or any other reward; • The voucher will expire on 30 November 2018; • FNB reserves the right to cancel vouchers should we suspect any fraudulent activity has occurred; • Should your virtual voucher be lost or stolen, neither FNB, Retailer nor its agents will be liable for any reimbursement of any kind; and • Voucher system downtime occurs from time to time and neither FNB, the retailer nor its agents will be held liable for any unforeseeable system breakdowns;
Data Usage and Privacy Policy	Participants in the Campaign understand and agree that, in order to offer the Promotion, eBucks may collect and use personal information about participants. This personal information may include participants’, first name, last name, email address, mobile number and in certain instances your image. In the unlikely event of a dispute, eBucks’ decision shall be final. eBucks reserves the right to amend, modify, cancel or withdraw any aspect of this Promotion in its sole discretion at any time without notice or liability. eBucks cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Promotional Campaign agree that eBucks will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a code, or from participation in this Campaign. The laws of the Republic of South Africa govern this Promotional Campaign. If any provision or part of these rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force. IMPORTANT

- You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the campaign rules.
