## CAMPAIGN RULES

Read these campaign rules carefully. These campaign rules (“rules”) explain your rights and duties in connection with this campaign. If you take part in this campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these campaign rules.

<b>Campaign Name:</b>	Superbalist.com: 20% off sitewide
<b>Promoter(s) Name(s):</b>	This campaign is run by FNB-eBucks, a business unit within FirstRand Bank Limited Registration No. 1929/001225/06 (“eBucks”) having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Superbalist.com. The person responsible for conducting the promotional campaign on behalf of eBucks is Schael Nefdt-Burger a Partner Growth Manager at eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
<b>The Discount:</b>	<p>eBucks Members who make either online purchases at <a href="http://www.superbalist.com">www.superbalist.com</a> or in-App purchases via the Superbalist app between 29 March 2018 and 30 April 2018, will qualify for 20% off the advertised retail price. <b>NB:</b> In order to qualify for the discount, you must spend a minimum of R600.</p> <p>The eBucks member will receive a discount mailer and/or a SMS relating to the discount. To participate, go to Superbalist.com or the Superbalist App to make a minimum purchase of R600, and enter the code <b>APRILUPDATE</b> on checkout to redeem the discount.</p> <p>The promoters reserve the right to substitute the discounted item with other items of equal or greater value. <b>Campaign closes:</b>	The Campaign ends on 30 April 2018 at 11:59:59pm. The promoter(s) reserve the right to extend the campaign by amending these campaign rules.
<b>Eligibility: Who qualifies to take part?</b>	This campaign is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is a member of the eBucks Rewards Programme.
<b>How to participate?</b>	You will receive a mailer and/or an SMS relating to the discount. To participate, go to either <a href="http://www.superbalist.com">www.superbalist.com</a> or the Superbalist app and apply the code <b>APRILUPDATE</b> on checkout to redeem the discount on your purchase of at least R600.
<b>Products to which the Discount is Applicable (“discounted item”):</b>	The discount does not apply to sale items. Minimum spend is R600.
<b>Is there a limit on the number of times you can use the discount voucher?</b>	The offer is limited to one discount code per customer.

<b>Data Usage and Privacy Policy</b>	Participants in the campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants', first name, last name, email address, mobile number and in certain instances your image. If any provision or part of these rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force. **IMPORTANT**

- You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the campaign rules.
