The person responsible for conducting the promotional campaign on behalf of eBucks is Schael Nefdt-Burger a Partner Growth Manager at eBucks. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.

<b>Campaign closes:</b>	The Campaign ends on 13 February 2018 at 11:59:59pm. The promoter(s) reserve the right to extend the campaign by amending these campaign rules.
<b>Eligibility: Who qualifies to take part?</b>	This campaign is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is a member of the eBucks Rewards Programme.
<b>How to participate?</b>	Members who meet the required minimum spend of R300 or more on the online purchase of a product from NetFlorist’s Valentine’s Day range for delivery on the 12 <sup>th</sup> or 13 <sup>th</sup> of February 2018 will automatically receive the free box of Lindt Lindor chocolates added to their order.

**IMPORTANT**
