Is there a limit on the number of times you can enter?	There is no limit on the number of entries. Every separate Africamp Glamping Boutique holiday booking purchase from eBucks Travel using your FNB/RMB PB card, eBucks or a combination of both will qualify for an entry into the draw.

How will winner(s) be chosen?	A random draw will take place during the week of 14 December 2020 to determine the winner.
