## **COMPETITION RULES**

If you take part in this competition and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these competition rules.

Competition Name:	eBucks Travel and Air Mauritius Competition
Promoter(s) Name(s):	This competition is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 ("eBucks")). An Authorised Financial service and Registered Credit provider. Having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Air Mauritius. The person responsible for conducting the promotional competition on behalf of eBucks is Calche Msali, a Marketing Manager at eBucks. In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".

Flights booking to which the Competition is Applicable:	This Competition is only valid on return flights to Mauritius on Air Mauritius booked via the eBucks Travel website or the FNB/RMB Private Bank App. Bookings and payments need to be made between 01 March and 31 March 2020.

Is there a limit on the number of times you can enter the Competition?	There is no limit to the number of times one can enter the Competition. Each return ticket to Mauritius in the main member's name will count as a separate entry.
