In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".</p>

Entries close:	<p>Entries close on 10 November 2018 at 23h59pm</p> <p>All entries must be received by us before 23h59pm on the closing date.</p> <p>The promoter(s) reserve the right to extend the competition. Notice of this will be posted in these rules.</p>
Winners announced on:	<p>The prize winner(s) will be notified by eBucks Rewards directly within 48 hours of the draw taking place, and will be contacted via their social media account, and then either telephonically or via email. The draw will take place during the week of 29 October 2018 at the eBucks Rewards premises and all winners will be published on the 'Promotions page' on eBucks.com.</p>
Eligibility: Who qualifies to take part?	<p>This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older as well as legal entities duly incorporated in accordance with the company laws of the Republic of South Africa and who are FNB customers.</p> <p>If the prize winner is not an FNB customer, they will be given an opportunity to switch to FNB within 7 days in order to claim the prize. Should the winner refuse to switch, they will not be eligible for the prize. The account further needs to be open and active, with the required minimum deposit in order to be eligible for the prize.</p>

The prizes	<p>The prize consists of one eB500 000 (R50 000) voucher to be spent on an eBucks Travel experience or product. The prize voucher has to be spent on a single travel experience and cannot be spent in phases. The prize is for the winner only; there is no obligation on</p>

How will winner(s) be chosen?	<p>All entries (a tag, comment and post) will be collected from all three influencer platforms (@South Africa, @Uncle Scrooch and @HlubiMboya1) over the competition period 10 October to 10 November 2018, and entered into the random draw. eBucks Rewards will conduct one random draw. The draws will take place at the eBucks Rewards premises and the winner will be published on the 'Promotions page' on eBucks.com.
