<b>Competition Name:</b>	Spend your eBucks at Engen and Stand a Chance to Win a share of R 150 000 in Engen Fuel Vouchers.
<b>How to enter?</b>	<ul style="list-style-type: none"><li>• Spend a minimum of eB2500 at Engen and stand a chance to win a share of R150 000 in Engen Fuel vouchers.</li><li>• Customers who spend the minimum amount of eBucks to purchase Fuel during the competition period, will qualify for an entry into the draw.</li><li>• Customers can spend their eBucks to purchase Fuel only at any Engen forecourts.</li><li>• Each eBucks spend transaction (including part-payments in eBucks) of at least eB2500 will count as an entry into the draw.</li><li>• Customers will have to spend eBucks at the Engen forecourt on the 15<sup>th</sup> day of each month, during the competition period to qualify. The competition days are 15 October 2025, 15 November 2025 and 15 December 2025.</li><li>• The customers who win a fuel voucher for October and November will receive the voucher within a month from each draw.</li><li>• The customers who win a Fuel voucher for spending eBucks on 15 December 2025, may only receive their prizes in January 2026.</li><li>• Please note customers are unable to spend eBucks in the Engen convenience shop. Only fuel purchases will qualify for the competition.</li></ul>
<b>The prizes</b>	<ul style="list-style-type: none"><li>• Ten customers will win a R5000 Engen 1App Fuel voucher, each month for the competition period.</li><li>• The draw will take place at the end of each month during the competition period and will be conducted by eBucks.</li></ul>
<b>Entries open:</b>	Entries open for 1 day each month, the dates are on 15 October 2025, 15 November 2025 and 15 December 2025 at 00:00am.
<b>Entries close:</b>	Entries close on 15 October 2025, 15 November 2025 and 15 December 2025 at 11:59:59 pm. The promoter(s) reserve the right to extend the Competition by amending these Competition rules.

<p><b>Is there a limit on the number of times you can enter?</b></p>	<p>There is no limit on the number of entries. Every separate minimum eBucks spend transaction will count as an entry into the draw.</p>
<p><b>Eligibility: Who qualifies to take part?</b></p>	<p>This Competition is open to any legal resident of the Republic of South Africa who is a natural or juristic person, 18 years of age or older at the time of entry and is a qualifying member of the eBucks Rewards Programme, excluding the categories of people listed below who cannot take part.</p>
<p><b>Who cannot take part?</b></p>	<p>The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them:</p> <ul style="list-style-type: none"> <li>a) Any employee of the promoter(s).</li> <li>b) Any director, member, partner, agent of, or consultant of the promoter(s).</li> <li>c) Any other person who directly or indirectly controls the promoter(s).</li> <li>d) Any supplier of goods and services in connection with this Competition.</li> <li>e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above</li> </ul>
<p><b>How winner(s) will be chosen?</b></p>	<p>A draw will take place at the end of each month during the competition period to determine the winners. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk &amp; Compliance team at eBucks. The winner will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the FNB Website within four days of the original draw date.</p> <p>The random entry drawn will be checked to establish whether it meets the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to contact such winner within 14 - 21 business days of the draw taking place using the primary contact details recorded on the winners' eBucks account. If the prize winner cannot be reached telephonically for any reason whatsoever through no fault of the Promoter after 3 days and at least 3 attempts, the prize will be awarded to the entrant who was drawn second or third and so on.</p> <p>After 21 business days should the Promoter have not succeeded in contacting 10 prize winners per month, the Promoter will conduct a further random entry draw. The above-mentioned process will be followed once again.</p> <p>This process will continue until the Promoter has successfully contacted a total of 10 prize winners per month.</p>

	<p>Please note that, potential winners will be asked verification questions to ascertain if they are not part of the excluded persons before prizes can be allocated.</p> <p>If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria.</p>
<p><b>How will winner(s) names be announced?</b></p>	<p>The prize winner/s may be announced on eBucks.com and Engen 1App, provided they consent to the announcement. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter, the prize will be awarded to the entrant who was drawn next.</p>
<p><b>How will winners receive the Prize</b></p>	<p>The voucher code will be loaded on the FNBAApp, the customer will log into the FNBAApp to retrieve the voucher code and insert it on the Engen 1App in order to redeem it from the Engen 1App.</p>
