

# Clicks & eBucks Seniors Month Competition Terms and Conditions October 2025

## Date these rules were first published: 1 October 2025 Date these rules were last changed:

Read these competition rules carefully. These competition rules ("rules") explain your rights and duties under this competition. If you take part in this competition or accept any prize, these rules will apply to you, and you agree that the person running the competition ("the promoter/s") can assume that you have read and agreed to be legally bound these competition rules.

Competition Name:	This campaign shall be known as the "Clicks Seniors Month Competition"
Promoter(s) Name(s):	The promoter of this competition is a FNB Cash Investments & Clicks, a business unit of First National Bank, a division of FirstRand Bank Limited with Reg. No. 1929/001225/06 ("FNB").  In these rules we refer to the above promoter(s) as "the promoter(s)" or "FNB/Clicks". We refer to participants and winners as "you".
Entries open and close:	Entries are open between the following times:
	Entries open on Wednesday, 01 October 2025 00:00.
	Entries close on Friday, 31 October 2025 23:59.
	FNB Cash Investments and Clicks reserves the right to extend the duration of the Competition, if necessary. Should the closing date be extended, a notification will be placed on the platform where the Competition was first published.
	All entries, fully completed as required, must be received by the promoter(s) on or before (time) the closing date.
What is the prize?	Win one of four R50 000 (Fifty Thousand Rand) - towards any Savings & Cash Investment Account
	The prizes are not transferable and cannot be exchanged for cash or for any other item. If, for any reason, FNB cannot provide any of the prizes, RMB will award an alternative prize of a similar value.
Winner/s announced on:	FNB will notify the winner within 14 business days after the final draw Friday
	The winner will be contacted on the cell phone number and/or email address linked to their Clicks Clubcard profile on the draw date. Should we be unable to contact a winner after three attempts after the draw, that winner will be disqualified from the competition and the prize will be forfeited by that winner. A replacement winner will be randomly drawn from the remaining qualifying participants in the draw using the

	same process used in the original draw. It is your responsibility to ensure that your contact information is always correct and up to date.
	Contacted winners will need to confirm that they accept their winnings for the promoter to pay out the funds to their cash investment account of choice.
	Please note: While prize winners may be asked to take part in publicity for the competition, however, prize winners have the right to refuse to do so.
Eligibility: Who qualifies to take part?	Clients must be at least 60 years of age and older and residing in the Republic of South Africa
Who cannot take part?	The following persons may not take part in this competition even if they qualify to take part. They will forfeit (give up) any prizes awarded to them:
	a) Any employee of the promoter(s).
	b) Any director, member, partner, agent of, or consultant of the promoter(s).
	c) Any other person who is directly or indirectly controls the promoter(s).
	d) Any supplier of goods and services in connection with this competition.
	e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above.
	f) Any person whose accounts and credit agreements with FNB or FirstRand Bank Limited are not in good standing. This means that none or your FNB and FirstRand Bank accounts and credit agreements should be overdrawn, or be in arrears, or be in default, or be subject to any legal process with FNB or FirstRand Bank. Legal process means any legal proceedings in any court of law involving you and FNB or FirstRand Bank, including but not limited to collections, liquidation and sequestration proceedings. Legal process however excludes debt review as contemplated in S86 of the National Credit Act 2005.
	However, even if the aforesaid disqualified persons participate in the competition or is subsequently disqualified, these competition rules will continue to apply between the disqualified persons and FNB.
How to enter and qualify for competition?	1.Client must be a member of the Clicks Customer Loyalty Programme ("Clicks ClubCard Programme");
	2.Must purchase at Clicks either in-store or online during the month of October 2025 and swipe his/her Clicks ClubCard during the purchase for in-store, or enter their ClubCard number for online;
	3. Must spend at least R400 (Four Hundred Rand) in one transaction;
	4. Must hold an FNB transactional account with all accounts in good standing;
	5. Must be an FNB eBucks member;
	6. Must pay with their FNB Card (Physical or Virtual card)
Is there a limit on the number of times you can enter?	There is no limit to the number of times one can enter. Multiple entries are allowed.

	Each R400 qualifies as one entry. For instance, R400 equals one entry, while R800 equals two entries.
How will winner(s) be chosen?	Four (4) winners will be drawn by random selection from all eligible entries by 30 November 2025. The judges' decision is final and no correspondence in this regard will be entered.

#### **General Rules**

### IMPORTANT - LIABILITY
