Read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

<b>Competition Name:</b>	eBucks 20 <sup>th</sup> Birthday Intercape Competition: Win Free travel for a year with Intercape
<b>Promoter(s) Name(s):</b>	This competition is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”)). An Authorised Financial service and Registered Credit provider. Having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000 in collaboration with Intercape Ferreira Mainliner. The person responsible for conducting the promotional competition on behalf of eBucks is Rylf Naidoo a Partner Growth Manager at eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
<b>How to enter?</b>	<ul style="list-style-type: none"> <li>• FNB/RMB Private Banking customers must use their eBucks at Intercape offices to purchase a Bus Ticket during the competition period to be entered.</li> </ul>
<b>The prizes</b>	<ul style="list-style-type: none"> <li>• One customer will win one year’s travel with Intercape and the winner will get 12 return tickets for a year.</li> <li>• Winner can only use a return ticket once a month.</li> <li>• Tickets valid for a period of 2 years calculated from the date the winner is notified.</li> <li>• Intercape tickets terms and conditions also apply.</li> <li>•</li> </ul>
<b>Entries open:</b>	Entries open on 20 November 2020 at 00:00:01am.
<b>Entries close:</b>	Entries close on 9 December 2020 at 11:59:59 pm. The promoter(s) reserve the right to extend the Competition by amending these Competition rules.
<b>Is there a limit on the number of times you can enter?</b>	There is no limit on the number of entries. Every separate qualifying purchase from Intercape using your eBucks will count as an entry into the draw.
<b>Winner announced on:</b>	<ul style="list-style-type: none"> <li>• Winners will be announced on the week commencing 14 December 2020.</li> </ul>
<b>Eligibility: Who qualifies to take part?</b>	This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry or juristic person and is a member of the eBucks Rewards Programme. Excluding the categories of people listed below who cannot take part.
<b>Who cannot take part?</b>	<p>The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them:</p> <ul style="list-style-type: none"> <li>a) Any employee of the promoter(s).</li> </ul>

	<ul style="list-style-type: none"> <li>b) Any director, member, partner, agent of, or consultant of the promoter(s).</li> <li>c) Any other person who directly or indirectly controls the promoter(s).</li> <li>d) Any supplier of goods and services in connection with this Competition.</li> <li>e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above</li> <li>f) Persons whose accounts are not in “Good standing”- <i>An account that's in good standing means it isn't overdrawn, in arrears or in default; you haven't missed a premium and you aren't undergoing sequestration, business rescue, collection or liquidation proceedings (excluding debt review proceedings). This applies to all FirstRand Bank accounts, including but not limited to FNB, Ashburton, WesBank, affiliates of WesBank and RMB Private Bank accounts.</i></li> </ul>
<p><b>How will winner(s) be chosen?</b></p>	<p>The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk &amp; Compliance team at eBucks. The winner will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the FNB Website within four days of the original draw date. The random entry drawn will be checked to establish whether it meets the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to contact such winner within 48 (forty-eight) hours of the draw taking place. If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria.</p>
<p><b>How will winner(s) names be announced?</b></p>	<p>Winner will be notified via a phone call by eBucks, advising the winner of the prize in the week commencing on 14 December 2020.</p>
<p><b>How will winner(s) receive the prize?</b></p>	<p>Intercape will contact the winner within 48hrs of the winner being notified by eBucks to arrange for the prize handover. The winner will be given an email address where he or she can directly make his or her monthly booking. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter, the prize will be awarded to the entrant who was drawn second.</p>
<p><b>Data Usage and Privacy Policy</b></p>	<p>Participants in the Competition understand and agree that in order to offer the Competition, we may collect and use personal information about participants. This personal information may include a participant's first name, last name, email address, mobile number and in certain instances your image. We will treat your information in total confidence and will not sell, share or rent this information to any other third parties. <p><b>General</b></p>	<p>No correspondence will be entered into regarding either this Competition or these Rules. In the unlikely event of a dispute, our decision shall be final. We reserve the right to amend, modify, cancel or withdraw any aspect of this Competition in our sole discretion at any time without notice or liability. We cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Competition agree that we will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a prize, or from participation in this Competition. The laws of the Republic of South Africa govern this Competition. If any provision or part of these Rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these Rules shall remain in force. #### **IMPORTANT**
