Read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

<b>Competition Name:</b>	eBucks 20 <sup>th</sup> Birthday Old khaki Competition: Win a R1000 voucher from Old Khaki
<b>Promoter(s) Name(s):</b>	This competition is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”)), an Authorised Financial services and Registered Credit provider having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000. The person responsible for conducting the promotional competition on behalf of eBucks is Rylf Naidoo a Partner Growth Manager at eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
<b>How to enter?</b>	<ul style="list-style-type: none"> <li>• The competition is open to all qualifying FNB/RMBPB account holders.</li> <li>• Customers must pay using their qualifying FNB/RMBPB cards, eBucks or a combination of both, either in-store or online with Old Khaki to qualify for an entry into the Competition draw.</li> <li>• We are not responsible for any lost, corrupted or delayed entries and these will be deemed invalid.</li> </ul>
<b>The prizes</b>	<ul style="list-style-type: none"> <li>• One customer will win a R1000 Cape Union Mart Group voucher.</li> <li>• The voucher prize will be subject to the Cape Union Mart Group’s voucher terms of use.</li> </ul>
<b>Entries open:</b>	Entries open on 20 November 2020 at 00:00am.
<b>Entries close:</b>	Entries close on 9 December 2020 at 11:59:59 pm. The promoter(s) reserve the right to extend the Competition by amending these Competition rules.
<b>Is there a limit on the number of times you can enter?</b>	There is no limit on the number of entries. Every separate purchase from Old Khaki either in-store or online using your qualifying FNB/RMB PB card, eBucks or a combination of both will count as an entry into the draw.
<b>Eligibility: Who qualifies to take part?</b>	This Competition is open to any legal resident of the Republic of South Africa who is either a juristic or a natural person, 18 years of age or older at the time of entry and is a member of the eBucks Rewards Programme. excluding the categories of people listed below who cannot take part.
<b>Who cannot take part?</b>	<p>The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them:</p> <ul style="list-style-type: none"> <li>a) Any employee of the promoter(s).</li> <li>b) Any director, member, partner, agent of, or consultant of the promoter(s).</li> <li>c) Any other person who directly or indirectly controls the promoter(s).</li> </ul>

	<p>d) Any supplier of goods and services in connection with this Competition.</p> <p>e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above</p>
<p><b>How will winner(s) be chosen?</b></p>	<p>A random draw will take place during the week of 14 December 2020 to determine the winner. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk &amp; Compliance team at eBucks. The winner will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the FNB Website within four days of the original draw date. The random entry drawn will be checked to establish whether it meets the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to contact such winner within 48 (forty-eight) hours of the draw taking place. If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria.</p>
<p><b>How will winner(s) names be announced?</b></p>	<p>Winner will be notified either through an email or phone call from eBucks, advising the winner that Old Khaki will make contact to award the winner the prize. Old Khaki will then contact the winner within 48hrs of the winner being informed of them winning. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter, the prize will be awarded to the next entrant who has met all the qualifying criteria.</p>
<p><b>Data Usage and Privacy Policy</b></p>	<p>Participants in the competition understand and agree that, in order to offer the Competition, eBucks may collect and use personal information about participants. This personal information may include participants' first name, last name, email address, mobile number and in certain instances your image. eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties. eBucks may disclose information if required to do so by law or if it is required to protect the safety, rights or property of the eBucks, our members, customers or the public.</p>
<p><b>General</b></p>	<p>No correspondence will be entered into regarding either this competition or these rules. In the unlikely event of a dispute, eBucks' decision shall be final. eBucks reserves the right to amend, modify, cancel or withdraw any aspect of this Competition in its sole discretion at any time without notice or liability. eBucks cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. The laws of the Republic of South Africa govern this Competition. If any provision or part of these rules is deemed void or otherwise unenforceable in law, then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force.
