

**Stand a Chance to Win Ten Times your Annual eBucks Spend Back  
COMPETITION RULES**

**Date these rules were last changed: 13 January 2023**

Read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

<b>Competition Name:</b>	Stand a Chance to Win Ten Times your Annual eBucks Spend Back
<b>Promoter(s) Name(s):</b>	This competition is run by FNB eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”)) an Authorised Financial Services and Registered Credit provider, having its principal place of business at 7 Merchant Place, Corner Fredman and Gwen Avenues, Sandton, Johannesburg, Gauteng, South Africa. The person responsible for conducting the promotional competition on behalf of eBucks is Bruce Gibbs, a Partner Growth Manager at eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
<b>How to enter?</b>	<ul style="list-style-type: none"> <li>• Customers who spend their eBucks during the competition period qualify for an entry into the draw.</li> <li>• Customers can spend their eBucks at any qualifying eBucks partners, in store or online.</li> <li>• Each eBucks spend transaction (including part-payments in eBucks) will count as an entry into the draw.</li> </ul>
<b>The prizes</b>	<ul style="list-style-type: none"> <li>• One hundred customers each will win ten times the amount of their annual eBucks spend, for the period January 2022 - December 2022, back in eBucks up to a maximum prize value of R100 000 (eB1 000 000).</li> <li>• The draw will take place at the end of the competition period and will be conducted by eBucks.</li> </ul>
<b>Entries open:</b>	Entries open on 1 October 2022 at 00:00am.
<b>Entries close:</b>	Entries close on 31 December 2022 at 11:59:59 pm. The promoter(s) reserve the right to extend the Competition by amending these Competition rules.
<b>Is there a limit on the number of times you can enter?</b>	There is no limit on the number of entries. Every separate eBucks spend transaction will count as an entry into the draw.
<b>Eligibility: Who qualifies to take part?</b>	This Competition is open to any legal resident of the Republic of South Africa who is a natural or juristic person, 18 years of age or older at the time of entry and is a qualifying member of the eBucks Rewards Programme, excluding the categories of people listed below who cannot take part.
<b>Who cannot take part?</b>	<p>The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them:</p> <ul style="list-style-type: none"> <li>a) Any employee of the promoter(s).</li> <li>b) Any director, member, partner, agent of, or consultant of the promoter(s).</li> <li>c) Any other person who directly or indirectly controls the promoter(s).</li> </ul>

	<p>d) Any supplier of goods and services in connection with this Competition.</p> <p>e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above</p>
<p><b>How will winner(s) be chosen?</b></p>	<p>A draw will take place during the week of 10 January 2023 to determine the winners. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk &amp; Compliance team at eBucks. The winner will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the FNB Website within four days of the original draw date.</p> <p>The random entry drawn will be checked to establish whether it meets the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to contact such winner within 14 - 21 business days of the draw taking place using the primary contact details recorded on the winners' eBucks account. If the prize winner cannot be reached telephonically for any reason whatsoever through no fault of the Promoter after 3 days and at least 3 attempts, the prize will be awarded to the entrant who was drawn second or third and so on.</p> <p>Please note that, potential winners will be asked verification questions to ascertain if they are not part of the excluded persons before prizes can be allocated.</p> <p>If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria.</p>
<p><b>How will winner(s) names be announced?</b></p>	<p>The prize winner/s may be announced on eBucks.com provided they consent to the announce. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter, the prize will be awarded to the entrant who was drawn next.</p>
<p><b>How will winners receive the Prize</b></p>	<p>The eBucks will be deposited directly into the eBucks accounts within 14 business days of them being contacted and the eligibility criteria verified.</p>
<p><b>Data Usage and Privacy Policy</b></p>	<p>Participants in the Competition understand and agree that in order to offer the Competition, we may collect and use personal information about participants. This personal information may include a participant's first name, last name, email address, mobile number and in certain instances your image. We will treat your information in total confidence and will not sell, share or rent this information to any other third parties. We may disclose information if required to do so by law or if it is required to protect the safety, rights or property of eBucks, our members, customers or the public.</p>
<p><b>General</b></p>	<p>No correspondence will be entered into regarding either this Competition or these Rules. In the unlikely event of a dispute, our decision shall be final. We reserve the right to amend, modify, cancel or withdraw any aspect of this Competition in our sole discretion at any time without notice or liability. We cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Competition agree that we will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a prize, or from participation in this Competition. The laws of the Republic of South Africa govern this Competition. If any provision or part of these Rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these Rules shall remain in force. Any violation of these Rules will result in the immediate disqualification of the transgressing participant from the Competition.</p> <p>Participants may be invited to participate in Public Relations activities and other marketing initiatives as organised by FNB for the purpose of this competition. Winners of the competition might be asked to participate in Social media advertising, including but not limited to Twitter, Instagram and Facebook by means of high-quality photos that will be displayed on FNB's social media pages as well as in FNB Branches. Participants and winners reserve the right to refuse such participation.</p> <p>We will not be held liable for any misrepresentation caused due to a copy error, typing error and/or omission that may occur on any of our competition material.</p>

<p><b>Tax Implications</b></p>	<p><b>IMPORTANT NOTICE: TAX IMPLICATIONS</b></p> <p><b>We strongly recommend that You obtain independent professional advice regarding any tax implications arising from the receipt, transfer or spend of any prize/s, awards and eBucks rewards obtained in respect of this incentive.</b></p> <p>You are fully responsible for any tax implications arising from or associated with any receipt, transfer or spend of any prize/s, awards and eBucks rewards due to You for participating in this incentive. You agree that You will not hold Us, FNB or FirstRand Bank Limited ("the Bank") liable and You hereby fully indemnify the Bank, and hold the Bank completely harmless, against all damages, claims and fines made against You or the Bank, including all legal costs on an attorney-and-own-client scale, to the extent to which such damages, claims and fines arise out of or are connected to any taxation relating to Your receipt, transfer or spend of any prize/s, awards and eBucks rewards or the charges in respect thereof.</p>
<p><b>Rule Amendments</b></p>	<p>These Rules cannot be modified or superseded except by FNB, in its reasonable discretion, in a written revision to these Rules posted on the FNB website and, at FNB' sole discretion, using other potential official Competition communication methods reasonably calculated to reach a majority of potential participants. A copy of these Rules can be found on the FNB website.</p>

**IMPORTANT**

- You agree to indemnify the promoters fully for any loss or damage the promoters may suffer because you breached the Competition rules. This means you agree to reimburse the promoters for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs means costs on an attorney and own client scale.
- You also agree to indemnify the promoters for any loss or damage you suffered because you took part in this Competition or used the prize. If you enter yourself, or use or accept the prize, you understand that you do so of your own free will. This means that you cannot hold the promoters legally responsible for any loss or damage or legal expenses you suffered because you took part in this Competition or used the prize.

**GENERAL RULES**

- You may not attempt to do anything to change the outcome of the Competition in any way.
- The judges' decision is final and no correspondence will be entered into. This means you cannot appeal any decision by the judges.
- The promoter(s) reserve the right to vary, postpone, suspend or cancel the Competition and any prizes (which have not yet been subject to a draw), or any aspect thereof, without notice at any time. The promoter(s) can change the rules of the Competition throughout the duration of the Competition. For convenience only, the date on which these rules were last amended will be shown below the heading. It is your responsibility to check the rules for amendments.
- The clauses in these rules are severable. This means that if any clause in these rules is found to be unlawful, it will be removed, and the remaining clauses will still apply.
- Where any dates or times need to be calculated in terms of this agreement, the international standard time: GMT plus two hours will be used.
- While the promoter(s) may allow you extra time to comply with your obligations or decide not to exercise some or all of our rights, or waive certain requirements, the promoter(s) can still insist on the strict application of any or all of its rights at a later stage. You must not assume that this means that the rules have been changed or that it no longer applies to you.
