COMPETITION RULES

Read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

Competition Name:	eBucks Festive Competition
Promoter(s) Name(s):	This Competition is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”)), an Authorised Financial services and Registered Credit provider having its principal place of business at 7 Merchant Place, 1 st Floor, 9 Fredman Drive, Sandton, Gauteng, South Africa, 2000, in collaboration with Takealot. The person responsible for conducting the promotional competition on behalf of eBucks is Patricia Sishi, a Partner Growth Manager at FNB-eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
The competition:	Customers stand a chance to 1 of 10 R2000 weekly Takealot vouchers
How to participate/enter?	Customers will need to use any of their qualifying FNB/RMB Private Bank cards on the Takealot platform during the competition period.
The prizes	Each customer stands to win a R2000 Takealot voucher. There will be 10 winners during the competition period.
Competition starts on:	Competition starts on 17 November 2021 at 00:00:01am
Competition ends on:	Competition ends on 24 December at 11:59:59 pm. The promoter(s) reserve the right to extend the Competition by amending these rules.
Is there a limit on the number of times a customer can enter?	There is no limit on the number of entries, there is however a minimum order value of R500 to qualify. Every separate qualifying purchase made at checkout of R500 or above online, excluding delivery, at Takealot using your FNB/RMB Private Banking or eBucks does qualify a customer.
Eligibility: Who qualifies to take part?	This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry, has an FNB/RMB Private Bank transactional account and is a member of the eBucks Rewards Programme.
Who cannot take part?	The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them: a) Any employee of the promoter(s). b) Any director, member, partner, agent of, or consultant of the promoter(s). c) Any other person who directly or indirectly controls the promoter(s). d) Any supplier of goods and services in connection with this Competition.

<p>How will winner(s) be chosen?</p>	<p>A draw will take place during the week of 24 November 2021 to determine the winner(s). There will be a weekly draw, the second draw takes place on the 1st of December 2021, the third draw on the 8th of December 2021, the fourth draw on the 15th of December 2021, the fifth draw on the 22nd of December 2021, the sixth and final draw on the 29th of December 2021. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk & Compliance team at Takealot.</p> <p>Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published via official Takealot social media platforms. The random entries drawn will be checked to establish whether they meet the Competition qualifying criteria and if so that entry will be the prize winners, subject to Takealot being able to contact such winners within 48 (forty-eight) hours of the draw taking place. If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria.</p>
<p>How and when will winner(s) names be announced?</p>	<p>The prize winners will be contacted directly by Takealot by 29th of December 2021 and the winner will be contacted via e-mail or contact number as per Takealot profile. No prize letter will be sent. The winner will also be announced on eBucks.com provided that the winner agrees to the announcement. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter, the prize will be awarded to the entrant who was drawn second or third and so on.</p>
<p>How will winners receive the prizes?</p>	<p>Prize will be delivered by Takealot via the winner's chosen platform, once confirmation is received.</p>

This personal information may include a participant's first name, last name, email address, mobile number and in certain instances your image. We will treat your information in total confidence and will not sell, share or rent this information to any other third parties. We may disclose information if required to do so by law or if it is required to protect the safety, rights or property of eBucks, our members, customers or the public.</p>

The laws of the Republic of South Africa govern this Competition. IMPORTANT
