

eBucks Travel: Flights on App -External launch competition (July)

COMPETITION RULES

Date these rules were first published: 11 June 2019

Date these rules were last changed: 26 June 2019

Read these Competition rules carefully. These Competition rules explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

Competition Name:	eBucks Travel: Book your flights on the FNB App & stand a chance to win an eB500 000 (R50 000) eBucks Travel voucher towards your next holiday
Promoter(s) Name(s):	This Competition is run by FNB-eBucks, a business unit within FirstRand Bank Limited Registration No. 1929/001225/06 ("eBucks") having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Calche Msali, a Marketing Manager at eBucks. In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
The Competition:	eBucks Members who make a purchase by booking flights on the FNB/RMB Private Banking App, with either their FNB/RMB Private Bank Card (Cheque or Credit), eBucks or a combination of both, qualify for an entry into a draw where they stand a chance to win an eB500 000 (R50 000) eBucks Travel voucher towards a holiday of their choice. The winner can only use the prize for a package that includes flights and accommodation and must be booked through the eBucks Travel Desk. The prize excludes all discounted flights. The promoters reserve the right to substitute the discounted item with other items of equal or greater value. Income or other taxes relating to the discount, if any, are the sole responsibility of the participants.
Entries open:	The Competition starts on 1 July 2019 at 00:00:01pm.
Entries close:	The Competition ends on 31 July 2019 at 23:59:59pm. The promoter(s) reserve the right to extend the Competition by amending these Competition rules. The winner will be chosen by means of a random draw taking place between 5 and 8 August 2019.
Eligibility: Who qualifies to take part?	This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is a member of the eBucks Rewards Programme. In order to qualify for an entry into the draw, the person making the payment must also be a traveler on the booking.
Who cannot take part?	The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them: a) Any employee of the promoter(s). b) Any director, member, partner, agent of, or consultant of the promoter(s). c) Any other person who directly or indirectly controls the promoter(s). d) Any supplier of goods and services in connection with this Competition. The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above
The prize:	An eB500 000 travel voucher towards flights and accommodation of the winner's choice that must be booked through the eBucks Travel Desk.
How to enter?	There are no entry fees. To enter, Participants must (between 1 and 31 July 2019), book flight/s on the FNB/RMB Private Banking App, with either their FNB/RMB Private Bank Card (Cheque or Credit), eBucks or a combination of both. By purchasing the product(s) as described above you will automatically be entered into the Competition. eBucks is not responsible for any lost, corrupted or delayed entries and these will be deemed invalid. Entries must be received by eBucks after the Competition opening time and no later than the Competition closing time. Each entry constitutes full and unconditional acceptance of these Rules. eBucks reserves the right to disqualify anyone in breach of these Rules. No telephonic, faxed, emailed or posted entries will be accepted.
How will winner(s) be chosen?	A random draw will take place between 5 and 8 August 2019 to determine the winner. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk & Compliance team. The winner will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the eBucks Website within four days of the original draw date. The random entry drawn will be checked to establish whether it meets the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to
