



1. Your travel benefits are based on the highest FNB transactional account you hold

For example: If you have an FNB Easy Smart Cheque account



the travel benefits you received will be based on your **FNB Aspire account.**

This means that you'll get R100 off per one-way domestic flight and R50 off per one-way bus ticket.


2. Your Annual Discount Savings is the total rand value of eBucks Travel savings you're allocated a year

This Annual Discount Savings amount is determined by the highest FNB transactional account you hold, and is allocated to you at the time of your September eBucks pay outs each year.





Here's an example of how this works

3. Family members of clients with an FNB Aspire account can travel at a discount as well

Children between the ages of 2 and 24 years old qualify for the same travel discount as the main member of an Aspire account (i.e. R100 off per one-way flight and R50 off per one way bus ticket) if they have an active FNB Youth account and are linked to that member's family profile on the FNB App.

Impact on Annual Discount Savings

The rand value of these family member discounts will also be deducted from your Annual Discount Savings.

If you book 2 more flight tickets for your child and partner in addition to your own ticket, here's how that would work:

FNB account	Remaining Annual Discount Savings after flight and bus ticket purchase	Remaining Annual Discount Savings after child's booking	Remaining Annual Discount Savings after partner's booking
FNB Aspire	R900 - R50 = R850	R850 - R100 = R750	R750 – R100 = R650




If your partner decides to book their ticket using their own profile instead, the rand value of that discount will be deducted from their own Annual Discount Savings which is dependent on their highest product they hold.

4. FNB Aspire clients can unlock SLOW Lounge visits



To unlock bonus SLOW Domestic and International Lounge visits, book flights through eBucks Travel on the FNB App using your FNB Aspire Credit Card.

You can unlock an additional 2 SLOW Lounge visits each for your children (2 – 18 years old) when you add them to your flight booking. They must have an active linked FNBy, FNBy Islamic or FNBy Next transactional account & be loaded on your Family Banking Profile.

To access a lounge and redeem your complimentary visits, generate a QR code on the FNB App and scan it at the SLOW Lounge entrance.

Add your spouse to your flight booking and they too can unlock 2 complimentary SLOW Lounge visits per year if they hold a qualifying FNB Aspire Credit Card. To use their visits, they need to generate a QR code on their FNB App and scan it at the SLOW Lounge entrance.
