COMPETITION RULES

Read these competition rules carefully. These competition rules (“rules”) explain your rights and duties in connection with this competition. If you take part in this competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound these competition rules.

Promoter(s) Name(s):	<p>This Competition is run by FNB-eBucks Rewards, a business unit within FirstRand Bank Limited Registration No. 1929/001225/06 (“eBucks”) having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000.</p> <p>The person responsible for conducting the promotional Competition on behalf of eBucks Rewards is Nadia Coelho, Head of Marketing at eBucks Rewards. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.</p>

Entries open:	Entries open on 10 October 2018 at 08h00am
Entries close:	<p>Entries close on 10 November 2018 at 23h59pm</p> <p>All entries must be received by us before 23h59pm on the closing date.</p> <p>The promoter(s) reserve the right to extend the competition. Notice of this will be posted in these rules.</p>
Winners announced on:	The prize winner(s) will be notified by eBucks Rewards directly within 48 hours of the draw taking place, and will be contacted via their social media account, and then either telephonically or via email. The draw will take place during the week of 12 November 2018 at the eBucks Rewards premises and all winners will be published on the ‘Promotions page’ on eBucks.com.
Eligibility: Who qualifies to take part?	<p>This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older as well as legal entities duly incorporated in accordance with the company laws of the Republic of South Africa and who are FNB customers.</p> <p>If the prize winner is not an FNB customer, they will be given an opportunity to switch to FNB in order to claim the prize. Should the winner refuse to switch, they will not be eligible for the prize. The account further needs to be open and active, with the required minimum deposit in order to be eligible for the prize.</p>
Who cannot take part?	<p>The following persons may not take part in this competition even if they qualify to take part. They will forfeit (give up) any prizes awarded to them:</p> <ol style="list-style-type: none"> Any employee of the promoter(s). Any director, member, partner, agent of, or consultant of the promoter(s). Any other person who is directly or indirectly controls the promoter(s). Any supplier of goods and services in connection with this competition. The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above.
How to enter?	Three selected influencers, @SouthAfrica, @Unlce_Scrooch, and @HlobiMboya1 will post pictures and videos of their travel experiences onto Instagram. To enter the Competition, like and comment on any of the posts and tag at least two friends.
The prizes	The prize consists of one eB500 000 (R50 000) voucher to be spent on an eBucks Travel experience or product. The prize voucher has to be spent on a single travel experience and cannot be spent in phases. The prize is for the winner only; there is no obligation on

	the winner to extend the prize to the two friends tagged in the entry. The Voucher will be subject to further terms of use which will be communicated to the winner.
Is there a limit on the number of times you can enter?	There is no limit on the number of entries; entrants may enter the draw as many times as they like by commenting (and tagging friends) on the various influencers' posts. Each comment will be considered as a separate entry.
How will winner(s) be chosen?	<p>All entries (a tag, comment and post) will be collected from all three influencer platforms (@South Africa, @Uncle Scrooch and @HlubiMboya1) over the competition period 10 October to 10 November 2018, and entered into the random draw. eBucks Rewards will conduct one random draw. The draws will take place at the eBucks Rewards premises and the winner will be published on the 'Promotions page' on eBucks.com. The random entry drawn will be checked to establish whether they meet the competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk & Compliance team. FNB will contact the winner first through Instagram DM, and then via phone through the FNB call centre.</p> <p>If the eligibility and qualifying criteria are not met or if a potential winner cannot be contacted within 2 (two) days after the first attempt through no fault of eBucks, further random draws will take place for entries that meet the eligibility and qualifying criteria and these entries drawn will be assessed as aforesaid by the panel of judges to determine the final winners.</p>
How will winner(s) names be announced?	<p>Winners will be announced on the 'Promotions page' on eBucks.com.</p> <p>Please note: While prize winners may be asked to take part in publicity for the competition, prize winners have the right to refuse to do so.</p>
Deadline for claiming prize(s)	If a potential winner cannot be reached by us, through no fault of ours, within 48 (forty-eight) hours after our first attempt to do so, the prize will be forfeited by that potential winner and be awarded to the next eligible winner assessed as aforesaid.

IMPORTANT:

- **You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules.
